3. I attach hereto marked "TPM1" a copy of my record of service, as captured by TEBA Limited.
4. As a sweeper, my duty was to clean the worksites underground. As a timber boy, my duty was to erect wooden poles to support the walls of the tunnels where blasting took place, to prevent them from collapsing. As a miner assistant, I was responsible for inserting the dynamite into the holes that had been drilled into the

tunnel walls and for spraying the rock with water after a blast to help reduce the dust created by the blast.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as blasting, crushing and transporting rock and ore.

6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: in the tunnels where the blasting took place, as well as in the tunnels we walked through to get to work underground. There was a system of compressors which would blow air into the tunnels underground for purposes of cooling the worksites, but it would only add to the existing high levels of dust underground, to which we were continuously exposed.

7. My former employer provided us with respiratory masks to use, but they were not provided regularly. Further, we had to purchase our own masks, and I struggled to afford to do so, as I used my salary to support my family in Lesotho.

8. I could see taste and smell dust while I worked underground and, after each shift, my uniform was covered in dust.

9. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.

10. In 2003 I was retrenched and I left work on the mines. I was 43 years of age. I was not aware of the rights that I have in terms of the Occupational Diseases in Mines and Works Act (ODIMWA) and the statutory compensation scheme provided for mineworkers in that Act.

11. I was diagnosed with silicosis in September 2012. I attach hereto the medical report confirming this diagnosis marked "TPM2". I did not have silicosis prior to working on the gold mines.

12. As a result of having silicosis, I am no longer able to perform any type of work to support my young daughter and my mother. Due to my ill health, I am physically weak, I suffer from shortness of breath and I am no longer able to do simple tasks without some help.

13. I have accordingly suffered the following damages:

13.1 loss of earnings;

13.2 medical expenses;

13.3 general damages for pain, suffering, loss of amenities of life, disablement and reduced life expectancy.

14. I, along with thousands of other mineworkers, have contracted silicosis as a result of our employment with Respondents' mines. I am committed to vigorously prosecuting this litigation on my own and my fellow mineworkers' behalf. I intend to obtain the largest recovery for the class consistent with good faith and sound judgment.

15. I understand that if I am appointed as a class representative, I owe a duty to all members of the proposed class to provide fair and adequate representation. I will continue to work in good faith with my counsel to obtain a fair recovery for the class.

16. I will not accept any payment for serving as class representative beyond my pro rata share of any recovery, except such reasonable costs and expenses (including lost wages and travel costs) directly related to the representation of the class as ordered or approved by the Court.

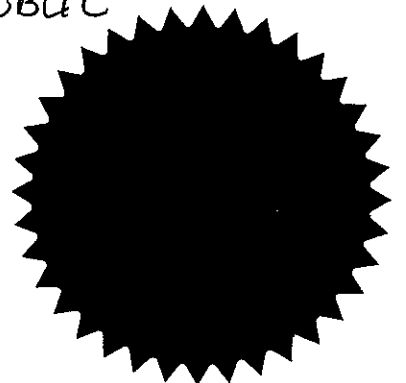

3. I attach hereto marked "**NM1**" a copy of my record of service, as captured by TEBA Limited.

4. As a machine operator, I operated various machinery used in the gold mining process, including the drilling machines. As a winch driver, my duties included manually operating the winch to pull the blasted rock and ore to the tipping point. As a water jet operator, my duties included removing waste from the skip with the water jet.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as drilling, blasting, and crushing and loading of ore and rock.

6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: the tunnels and stopes where blasting took place, as well as in the worksites when blasting took place on another level of the mine during a shift.

7. I could frequently see, taste and smell dust underground and, at the end of each shift, my uniform was covered in dust.

8. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.

9. I was retrenched in 2009, at the age of 42, as my employer found me to be medically incapacitated and no longer able to perform my duties underground. In my exit medical examination I was found to be suffering from an "occupational lung disease", but the specific disease was not indicated on the exit medical certificate (a copy of which is attached marked "NM2").

10. I was diagnosed with silicosis in July 2012. A copy of the medical report confirming this diagnosis is attached marked "NM3". I did not have silicosis prior to working on the gold mines.

11. As a result of having silicosis, I suffer from shortness of breath and I struggle to walk even short distances. I am no longer able to work to support my family and I am no longer able to partake in the activities of my community. My greatest concern is that, knowing that I have silicosis, I will need medical treatment and care which neither I, nor my family can afford.

12. I have accordingly suffered the following damages:

12.1 loss of earnings;

12.2 medical expenses;

12.3 general damages for pain, suffering, loss of amenities of life, disablement and reduced life expectancy.

13. I, along with thousands of other mineworkers, have contracted silicosis as a result of our employment with Respondents' mines. I am committed to vigorously prosecuting this litigation on my own and my fellow mineworkers' behalf. I intend to obtain the largest recovery for the class consistent with good faith and sound judgment.

1. I am a widow and I reside at Ha-Motsoane, Naleli, Lesotho.
2. I was married to my late husband, LEKHOOANYANA ISAAC LEBITSA, on 15 September 1986 and I attach hereto a letter confirming our marriage ("**MRL1**"), together with a translation ("**MRL2**").
3. My late husband was a former gold mineworker who worked underground in the following mines during the dates set forth below:

(1) Mine	(2) Dates
St Helena Mine	1972 - 1975
Vaal Reefs Mine	1977 - 1998

4. I attach hereto marked "**MRL3**" a copy of my late husband's history of service in the gold mines as recorded by TEBA Limited.

5. My late husband left work on the mines when his former employer found that he was medically incapacitated and that he was no longer able to perform his duties. In early 2005, my husband was certified to be suffering from tuberculosis and silicosis in the second degree by the Medical Bureau for Occupational Diseases (MBOD) (see the attached copy of the MBOD certificate marked "MRL4").
6. On 30 April 2010, my husband passed away. He was 55 years of age. As per the copy of the attached death certificate marked "MRL5", the cause of his death was Tuberculosis. I am advised that scientific research shows that the risk of dying from tuberculosis is three times higher in silicotic mineworkers than those without silicosis.
7. My husband supported me whilst he was working on the mine. Consequent to working on the mines, he developed silicosis and, as a result, he left work on the mines due to ill health at the age of 42, long before the normal retirement age of 65 years. When he returned home from the mines, his health deteriorated and, as he became weaker, his ability to support his family was severely undermined. The support he provided me was fully terminated when he passed away in 2010.
8. Accordingly, as a result of my late husband contracting silicosis and being retrenched prior to the normal age of retirement due to his ill health, I suffered a reduction of support when he left work on the mines. Thereafter, when he died, the support provided by him was completely terminated.

8. Accordingly, as a result of my husband contracting silicosis and being retrenched prior to the normal age of retirement due to his ill health, I suffered a reduction of support when he left work on the mines. Thereafter, when he died, the support provided by him was completely terminated.

9. My late husband, along with thousands of other mineworkers, had contracted silicosis as a result of their employment with Respondents' mines. I am committed to vigorously prosecuting this litigation on my deceased husband's behalf, as well as on behalf of other dependants of deceased mineworkers. I intend to obtain the largest recovery for the class consistent with good faith and sound judgment.
10. I understand that if I am appointed as a class representative, I owe a duty to all members of the proposed class to provide fair and adequate representation. I will continue to work in good faith with my counsel to obtain a fair recovery for the class.
11. I will not accept any payment for serving as class representative beyond my pro rata share of any recovery, except such reasonable costs and expenses (including lost wages and travel costs) directly related to the representation of the class as ordered or approved by the Court.
