I, the undersigned,

MYEKELWA MKENYANE

do hereby make oath and say :

1. I am an adult ex-gold mineworker residing at Madiba Location, Bizana.

2. I worked underground on the following mines in the following positions during the dates set forth below:

(1) Mine	(2) Dates	(3) Title/Position
Kinross Gold Mine	1975 – 1976	General worker
Free State Saaiplaas	1976 – 1998	General worker, winch driver
Masimong Division	1998 – 2005	Gang supervisor, development team leader
Harmony Gold Group	2005 – 2009	Stope Team Leader

3. I attach hereto marked "MM1" a copy of my record of service, as captured by TEBA Limited.



4. As a general worker, I placed the stones in a position to be scraped away and, after the large rocks had been removed, I would sweep the area clean. As a winch driver, I pulled the scraper to move the rock from the stope face into the tipper. As a gang supervisor, I watched for any dangers that the loco drivers might come across. As development team leader, I supervised the loader drivers who tipped the rock into the loco and used a safety lamp to make sure there were not dangerous stones near the development team. As the stope team leader, my duties included supervising the winch driver, looking for gold, and checking the supports to ensure that they were stable and that there would not be any accidents.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as drilling, blasting, and crushing rock. It was my responsibility to check the dynamite before it was ignited and I was, therefor, often near the explosion. Blasting would take place during the shifts that I worked and, when this happened, I would remain underground. As a result, I was exposed to the large amount of dust that was generated when blasting took place. I did not wear a respiratory mask or any other equipment to help reduce the inhalation of dust.



6. On occasion, rocks would be too large to clear the grizzly, and, using a hammer, I would break the rock into smaller pieces so that they could fit through the grizzly. A large amount of dust was created through this process as well.
7. On a daily basis, I and my co-workers breathed silica dust throughout the mines where I worked, but especially along the loco path and at the tipping point for rock and ore.
8. I was provided with a small respiratory mask by my former employers once a week, but I found it difficult to wear because it restricted the airflow into my lungs. Despite this, I wore the mask when it was provided, because I was afraid of what effect the inhalation of all the dust was having on my health. Only the workers in the parts of the mine with the highest concentration of dust would be provided with masks and the masks were only provided when the conditions were especially dusty.
9. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.
10. I was diagnosed with silicosis by the Medical Bureau for Occupational Diseases (MBOD) on 31 January 2003 (attached is a copy of the certificate received from



the MBOD marked "MM2"). By that time, I had spent approximately twenty-seven years working underground on the gold mines. I did not have silicosis prior to working on the gold mines. Despite having silicosis, I continued to work on the mine until 2009 when I had a stroke.

11. As a result of having silicosis, I find it difficult to breathe, I have to stop when I walk long distances, I have a constant pain in my chest; and I cough for long periods of time. I have trouble washing myself and eating.

12. I have little quality of life and I am unable to get a job to support my family. My dependants need financial assistance from me to pay for school uniforms, school fees, and food, but I have little assistance to give them, as I struggle to cover my own monthly expenses.

13. I have accordingly suffered the following damages:

14.1 loss of earnings;

14.2 medical expenses;

14.3 general damages for pain, suffering, loss of amenities of life, disablement and reduced life expectancy.

14. I, along with thousands of other mineworkers, have contracted silicosis as a result of our employment with Respondents' mines. I am committed to vigorously



prosecuting this litigation on my own and my fellow mineworkers' behalf. I intend to obtain the largest recovery for the class consistent with good faith and sound judgment.

15. I understand that if I am appointed as a class representative, I owe a duty to all members of the proposed class to provide fair and adequate representation. I will continue to work in good faith with my counsel to obtain a fair recovery for the class.


16. I will not accept any payment for serving as class representative beyond my pro rata share of any recovery, except such reasonable costs and expenses (including lost wages and travel costs) directly related to the representation of the class as ordered or approved by the Court.

17. The contents of this affidavit, as well as the effect of signing it, have been fully explained to me in my first language, and I understand the contents hereof.

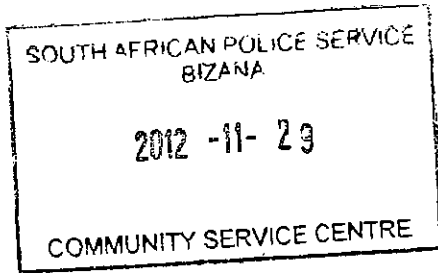

1. I am an adult former gold mineworker residing at Nyaka Location, Bizana.
2. I worked underground on the following mines in the following positions during the dates set forth below:

3. I attach hereto marked "MS1" a copy of my record of service, as captured by TEBA Limited. I did not work at Venterspost Gold Mine and I do not know why my TEBA work record reflects that I did.

4. As a cleaner I was responsible for cleaning worksites underground by way of watering down and use of compressed air. As the chief boss assistant, I was a general assistant to my manager in performing his duties.
5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as blasting; drilling, crushing and transporting rock and ore.
6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: tunnels (the use of compressed air to clean worksites created dust), and at the tipping station where waste rock and ore was loaded into loco carriages to be taken to the surface of the mine, as it was often necessary to drill or blast larger rocks into smaller pieces in order to fit into the carriages.
7. Blasting would often take place during shifts that I worked underground. My co-workers and I would not be taken to the surface for these blasts, and a tremendous amount of dust was created by the blasts, to which we were all exposed.
8. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to

be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.

9. At the end of my contract in 1995, I went on leave and got ill. I was too ill to return to work on the date I was due to return and, as a result, I was retrenched. I was 40 years old.
10. In July 2012, I was diagnosed with silicosis. I attach the medical report confirming the diagnosis marked "**MS2**". Prior to working on the mines, I did not have silicosis.
11. I am not aware of the statutory compensation scheme for mineworkers with occupational lung diseases provided for in the Occupational Diseases in Mines and Works Act (ODIMWA) and my former employer did not advise me of my rights in terms of ODIMWA.
12. As a result of having silicosis, I am no longer able to perform any type of work to support family. One of my children has had to leave school, as I can no longer afford to pay the school fees. I am physically weak; I have coughing fits, which often wake me during the night.
13. I have accordingly suffered the following damages:

2. I worked underground in the following mines in the following positions during the dates set forth below:

3. I attach hereto marked "ZM1" a copy of my record of service, as captured by TEBA Limited.

4. As a timber boy, my duty was to erect timber poles in the tunnels to prevent the walls from collapsing during blasting. As a winch driver, I pulled the scraper to

move the rock from the stope face into the tipper. As a team leader, I was responsible for blasting underground.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as drilling, blasting, and crushing rock. It was my responsibility to check the dynamite before it was ignited and I was, therefore, often near the explosion. A large amount of dust was generated from the blasts, to which I was exposed, as I remained underground during blasting.

6. On occasion, rocks would be too large to be transported by the winch, and, using a hammer or a small bomb, I would break the rock into smaller pieces so that it would fit. A large amount of dust was created through this process as well.

7. On a daily basis, I and my co-workers breathed silica dust throughout the mines where I worked, but especially in the stopes. I could often see, taste and smell dust in my working environment underground.

8. My former employers provided me with a respiratory mask to wear underground, but it was not practical for me to wear during my work, as it was unbearably hot underground and the mask made it difficult to work.

9. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.
10. I was diagnosed with silicosis by the Medical Bureau for Occupational Diseases (MBOD) in 2008 (attached is a copy of the MBOD certificate marked "ZM2"). I did not have silicosis prior to working on the gold mines.
11. In 2011, my former employer found that I was permanently unfit for employment and I was retrenched. Attached marked "ZM3" is a copy of my former employer's finding in this regard, as well as a copy my exit medical certificate confirming that I have silicosis marked "ZM4". I was 51 years old.
12. I was not aware of the dangers of being exposed to silica dust underground and the risk that I faced of developing silicosis as a result of such exposure. Due to the fact that I have silicosis, I am no longer able to work to support my wife and children. I cannot even afford the school fees for my children to attend school. I am physically weak and have constant difficulty breathing. I feel helpless as I can no longer do things for myself as I could before, and I can no longer partake in community activities.

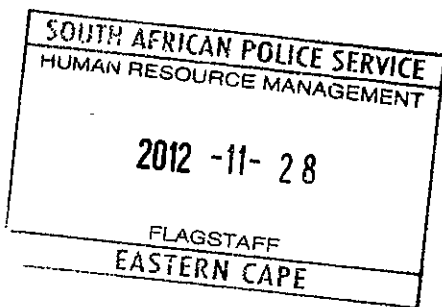





12.3 general damages for pain, suffering, loss of amenities of life, disablement and reduced life expectancy.

After I was diagnosed with silicosis in 2005, I stopped working underground and worked on the the surface of the mine as a loco operator. 
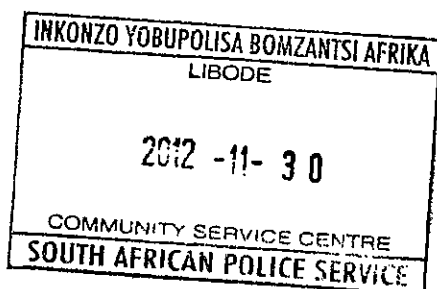

4. As a transporter, my duties included unpacking the support beams that would be transported by the locos. As a pipe layer, I would install the pipes that carried water for watering the walls underground and for drinking. As a team member, I would place the supports under the rock to prevent a collapse. As a machine operator, I operated the boring machine. As a loco driver I transported people, rocks, pipes, and all the equipment that was used underground. As a loco team leader, I would instruct the loco drivers on how to operate the locos. As a construction team leader, I continued to give instructions to the loco and loader drivers and I was responsible for the safety of all the drivers. As a team leader, I would also change the air filters in the ventilation system underground.

5. During my time working at Western Deep Levels, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as drilling, blasting, crushing, loading and transporting rock and ore. The highest concentration of dust would be released when the loader was unpacked. There was more dust in the mines during the night shift because the dust would remain in the air underground at the end of the day shift. It was more difficult to work the night shift because of the higher dust levels in the work site, but we had no choice, as we had to work the shifts that were assigned to us.

6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: in the tipper after clearing blockages, areas where compressed air was used, and around the ventilation shaft when the filters were changed.
7. I was trained to use an emergency respiratory pack a few months before I was retrenched by my former employer. While we were trained to use the emergency respiratory packs, we were not always given one. If we were given a respiratory pack, it was only to be used in emergencies when the airflow was cut-off.
8. It would take me up to 45 minutes to walk to my worksite underground. During the walk, I noticed that the tunnels were full of dust to which I was exposed. Water was used to control the dust levels underground, but it was merely a temporary measure of control in that, after spraying the worksite with water, the dust would soon return. There was no way to avoid the dust underground. When I changed the air filters, I would inhale large quantities of dust. The dust would accumulate on my face, nose, eyebrows, and my clothes.

13. I have trouble breathing, walking long distances, and performing any manual labour. I am generally unfit. I try to support my family, but I am now incapable of providing them with an adequate income for basic supplies, such as food, schooling, and clothes. I have to limit the time I spend working in my backyard farm because of the condition of my lungs; I can work around thirty minutes at

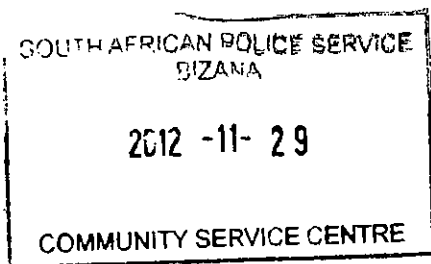

1. I am an adult former gold mineworker residing at Ha Motemekoane, Maseru, Lesotho.

2. I worked underground on the following mines in the following positions during the dates set forth below:

3. I attach hereto marked "ML1" a copy of my record of service, as captured by TEBA Limited.

4. As a pipe attendant, my duties included installing new pipes and fixing the old pipes that carried water and pressurized air for drilling. As a stope team

member, my duties included placing and removing the timber supports in the stopes. As a winch driver, my duties included manually operating the winch to pull the blasted rock and ore to the tipping point. As a stope team leader, my duties included marking the places where supports needed to be placed in the stopes.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as drilling, blasting, crushing, and loading rock. I often worked the afternoon shift, right after blasting took place underground. When I arrived at my work station it would be full of dust and I could smell the blasting fumes.
6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: in the shaft, in the tunnels, and in the stope sites where blasting took place.
7. I did not start receiving a respiratory mask to cover my face until 1980. It was compulsory to wear the masks after that point. We were only given new masks when our old ones had been worn down, not at any specific interval. I never received an emergency respiratory pack.

8. I often saw dust coming from the levels working above us. The dust came from the tipping point where all the rock and ore was being dumped into the locos for transport. At the end of my shift my uniform, face and hair were always covered in dust. I could also taste and smell the dust underground. After blasting, even if we waited for a longer period than usual before going back underground, there was always dust at our work site.

9. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.

10. I left work on the mines in 2003 as I was ill and I was no longer able to work underground. I was 53 years old.

11. I was diagnosed with silico-tuberculosis in May 2012. I attach hereto the medical report confirming this diagnosis marked "ML2". I did not have silicosis prior to working in the gold mines.

12. I did receive an exit medical examination when I left the mine, but I never received any medical records or reports relating to the examination. I was informed of my rights under the Occupational Diseases in Mines and Works Act (ODIMWA) when I was sent home, but I was not informed that I could have a

medical examination every two years at the expense of the South African state. I only found out I that I have silicosis went I was sent for medical screening by my attorney, Richard Spoor Attorneys.

13. As a result of having silico-tuberculosis, I make a wheezing sound in the morning when I try to breathe, and this is accompanied by sharp pains in my chest. I experience shortness of breath whenever I walk uphill, long distances or when I walk quickly. I can no longer run or do anything that requires a normal amount of strength.

14. Due to my lung condition, I am unable to work. I do not receive a pension and my only income is from the few crops I am able to grow and sell each month. I have four dependants, including my wife, my daughter, and my two grandchildren. I am no longer able to help with the farming activities on which my family relies to survive; instead my family must ask others in the community to help. We only have access to the very old farming equipment that is very heavy and I no longer have the strength to use that equipment.

15. I have accordingly suffered the following damages:

15.1 loss of earnings;

15.2 medical expenses;

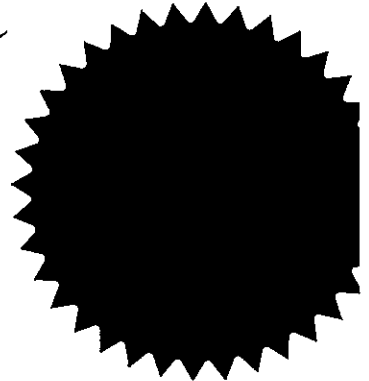



2. I worked underground in the following mines in the following positions during the dates set forth below:

3. I attach hereto marked "JL1" a copy of my record of service, as captured by TEBA Limited.
4. As a member of the stope team, my duty was to secure the walls of the tunnels so that they did not collapse during blasting. As a winch driver, my duty was to load the rock and ore into the loco carriages for it to be taken to the surface. As a

loco driver, I was responsible for pulling the container full of rock and ore and tipping its contents into the skip, for it to be taken to the surface of the mine. As a loader driver, I would load the rock and ore into the loco carriages.

5. During my time working for these mining companies, I was frequently and regularly exposed to silica dust released during day-to-day mining activities. This exposure occurred from working with and near activities such as blasting, crushing and transporting rock and ore. When blasting took place during a shift, there would be so much dust created that you could barely see the person right next to you; all you could see was their headlamp.
6. On a daily basis, I and my co-workers breathed silica dust in the following areas of the mines: in the tunnels where the blasting took place, as well as in the areas where the rock and ore was loaded into the loco carriages to be taken to the surface.
7. I was given a respiratory mask to wear while I worked underground, but it was not replaced very often. When I reported to my supervisor that I needed a new mask, I would have to wait before a new mask was issued to me.
8. I could see taste and smell dust while I worked underground. Working in a dusty environment underground was the norm. After completing each shift underground, my uniform was covered in dust.

9. Prior to being permitted to work on the gold mines, I was medically tested for the presence of occupational lung diseases, including silicosis, and was deemed to be well and fit to work underground. Thereafter, I was examined periodically for the presence of silicosis and other occupational lung diseases.

10. In 2004, I was certified to be suffering from silicosis by the Medical Bureau for Occupational Diseases (MBOD). As a result of having silicosis, my former employer found that I was no longer able to perform my duties underground and I was retrenched. I was 54 years old. 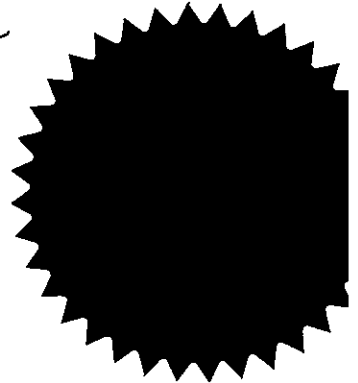
