

ISAZISO ESIPHATHELENE NESICELO SESINXEPHEZELO ESIHLONGOZWAYO

Uma njengamanje noma UBUNGUMVUKUZI WEGOLIDE eNingizimu Afrika, noma ingasiphi isikhathi ngemva komhla ziyi-12 kuMashi 1965, futhi wawuvuleleke kuthuli lwe-silica noma uma ungenwe i-silicosis noma isifo sofuba (“TB”) NOMA UNGUMUNTU OBETHEMBELE KUMVUKUZI (isib., unkosikazi, ingane noma umlingani okudala ezwana naye kodwa angashadile naye) futhi lowo mvukuzi esashona, SICELA UFUNDE LESI SAZISO NGOKUCOPHELELA NGOBA KUNGENZEKA SIBE NOMTHELELA EMALUNGELWENI AKHO.

Uma kukhona enye intshisekelo onayo ngokuphathelene nesinxephezelo sokukhokhelwa esihlongozwayo kumele ukuthi nawe ufunde lesi saziso.

ISICELO SESINXEPHEZELO ESIHLONGOZWAYO

Izinkampani eziyisithupha, i-African Rainbow Minerals, Anglo American SA, AngloGold Ashanti, Gold Fields, Harmony, Sibanye-Stillwater kanye nezinye izinkampani ezisebenzisana nazo (“izinkampani zezimayini zegolide ezibambe iqhaza”) sezifinyelele esivumelwaneni sokukhokhela ukunxephezela ngaphansi kwemibandela ethile abavukuzi begolide okumele bahlomule kanye nabantu ababethembele kulabo bavukuzi begolide asebashona. Lesi sicele sokunxeshelwa esihlongozwayo sizokhokhela izicelo zokukhokhelwa ezifakelwe izinkampani zezimayini zegolide ezibambe iqhaza ngenxa yesicelo sokukhokhelwa esifakwe eNkantolo Ephakeme ngokuphathelene nalokhu:

- ukulimala kanye nokulahlekelwa okwenzeke kubavukuzi abangenwa yi-silicosis kanye/noma isifo Sofuba ngesikhathi besebenza ezimayini zegolide ezithile eNingizimu Afrika, kanye
- ukulimala kanye nokulahlekelwa kwabethembele kubavukuzi abashona ngenxa yalezi zifo.

Lesi sinxephezelo sokukhokhelwa esihlongozwayo sinemigomo ethile futhi kumele sigunyazwe Inkantolo Ephakeme ngaphambi kokuthi senzeke.

Uma sigunyazwa isicelo sokunxeshelwa futhi kuhlangabezana nezimiso zaso, Isikhwama Semali Esiyiwe (Trust) esibizwa ngokuthi i-Tshiamiso Trust sizosungulwa futhi sizoba khona iminyaka eyi-13.

Wonke amalungu amelwe ngokwesicelo sokunxeshelwa, ngaphandle kwalawo akhethe ukungangeni esinxephezeleni, kuzofanela ukuthi **afake isicelo sokukhokhelwa ku-Tshiamiso Trust** ukuze bathole ukunxeshelwa ngemali.

Labo abafanele ukufaka isicelo sokukhokhelwa kuzofanela athole imali azoyikhokhelwa kanye ephakathi kuka-R10 000 no-R250 000, okuncike kuhlobo kanye nokuba mandla kwesifo. Ezimweni ezithile ezikhethekile, le mali ingakhushulwa ize ifinyelele ku-R500 000. Umuntu okufanele afake isicelo sokukhokhelwa umuntu oyilungu lanoma yimaphi lawa maqembu futhi ohlangabezana nalokho okufunwa yi-Tshiamiso Trust ukuze athole ukunxeshelwa ngemali.

Izimayini zezinkampani zegolide ezibambe iqhaza nazo kudingeka ukuthi zikhokhele abammeli babafake isicelo sokunxeshelwa inani elithile ngokuphathelene nezindleko zezomthetho bese zikhokhela nokwenganyelwa kwe-Tshiamiso Trust.

UBANI OYILUNGU ELIMELWE NGOKUPHATHELENE NESINXEPHEZELO?
